- 3. Statement by the Social Chair (Elmer Zapata Mercado) emailed to the secretary account. Included below verbatim.
 - a. Dear members of the General Council,

For the past three years I have served the GRO as the Social Chair. I have done my work with pleasure. During the discussion of the election for this coming year's Social Chair, several claims and statements were made about my person and my character, and I will like to address these statements today. Two weeks ago, there was a troubling part of the carried elections, that happened when the elections official, someone who is supposed to be impartial in this process, took the floor to make statements in favour of or against candidates. This compromises the integrity of the process. I learned the day after the election that a current co-chair accused me of making a racist comment to him. I was very confused, and immediately followed up to find out what he believed I had said. It guickly became clear that he misheard a comment I made nine months ago, and chose not to give me the benefit of the doubt by asking me if he had heard correctly. I have seen him many times in social and professional contexts in the nine months since then, and would have appreciated the opportunity to correct the misunderstanding in a more timely, and far less public, way. I am ready to let all of this go, and move on with my career. Before I do that, I would like to express my belief that such actions by members -- and particularly by the leaders -- of a professional body like this one are unprofessional and reprehensible. No one in a professional role of this nature should have the right to defame and/or slander the name of a colleague without attempting to directly address it within the professional context first, and without giving the colleague in question the opportunity to defend themselves. At this time I would like to acknowledge that I have learned how my behavior, my tone, my way of talking, and sometimes my poor choice of words, can make some members of this body uncomfortable. To that matter, I would like to offer some clarification. The intention of my words was never to attack, shame or belittle anyone here. I have a tendency to speak with intensity, even with people that I agree with, that I believe is largely due to my cultural upbringing. Speaking passionately, and perhaps aggressively, is considered normal in Puerto Rico, and I only recently came to understand how

this violates norms here. The fact is, I agree with the fundamental views of most people here, even when I have different ideas on how to approach them. One of the things I have loved most about being in the GRO is the opportunity to freely exchange ideas with others who had different perspectives, but I am sorry that I often engaged in that exchange with a demeanor that implied my disagreement was personal. From my end, I will make a sincere effort to alleviate these kinds of misunderstandings in the future, by being more conscious of my tone and demeanor. I hope that if in the future my tone or behavior comes across the wrong way, that members of this Council will be sympathetic to my cultural background and afford me an opportunity to explain myself. With the admirable cultural and political diversity the council represents, I think it is all the more important that we are able to work together to prevent future misunderstandings in this way. I would like to add that I will be proud to continue to support the GRO's mission when needed. Thank you for your attention.
