

#### **FERPA and Parental Notification**

The parents and/or legal guardians of students under the age of twenty-one (21) at the time of disclosure may in the University's discretion be notified if their child is found responsible for certain violations of the University's alcohol or drug policies, and in cases that result in suspension and expulsion.

#### Professional Staff in the halls

- Residence Directors (RD): Masters holding professionals live in each community
- RDs work with our student staff (RAs) to create safe welcoming communities that provide residents with many opportunitie to engage and build community
- RDs are the principal professional staff in the halls to work with students for any concerns with Community Living guidelines or Student Conduct Code
